- Festival hours are 5-10 p.m. on Friday and Saturday from 10 a.m. until 10 p.m.
- Check-in and set-up starts at 2 p.m. on Friday. (No Earlier than 2:00 p.m.) Check in at the Main entrance.
- Must be set up by 5:00 p.m. on Friday and 10:00 a.m. on Saturday. (No Exceptions and/or late set ups allowed)
- Vendors must leave their areas as clean as when you started
- We will accept checks, cash, and credit cards for your booth space. Please make checks payable to the Duncanville Lions Club. You can download the application at www.smokinbluebbqfest.com
- We do not provide electricity. If you need it, you must provide it and **it must be a quiet generator! (such as a Honda)**
- Bring your own tables, tents, chairs, display units, and anything else you need to present your items (None provided)
- Spaces are reserved but preference is given to the first vendors to sign up)
- The park is fenced off and Police Security is available all night. You may leave your booth set up at your own risk.
- Checks & cash applications may be turned in to the Duncanville Chamber Office at 300 E. Wheatland Rd. Credit cards will be run by the Duncanville Lion's Club. (The Chamber can't take Credit Cards)
